01 Who we are

We are the World Federation for Animals (WFA), a membership organisation founded in 2020 by and for national, regional, and international animal protection organisations. WFA is the result of these organisations' decision to join forces and work together towards a broad representation of the interests of animals in international policy fora.

By harnessing the collective strength of the animal protection movement, we tap into a momentous opportunity to ensure that animals are, at last, considered within global policymaking.

As of August 2024, WFA has 73 members.

Our governance. WFA is governed by the General Assembly, with representatives of all its member organisations. The Board is currently composed of 19 representatives of its founding members. The Secretariat is led by a Chief Executive Officer and composed of policy, membership, and communications experts.



02 What we do

We aim to improve the well-being of all animals and end their exploitation and suffering worldwide. To do so, we work towards bold and audacious goals:

- The United Nations recognises the importance of animal welfare with dedicated international instruments.
- Present and future international health and environmental regimes are strengthened by integrating animal welfare.
- International trade, aid, subsidy and investment rules improve animal welfare.

We will achieve our goals in three key ways:

- Researching, curating and sharing policy analysis and information.
- Coordinating and elevating NGOs' global advocacy efforts.
- Advocating on behalf of the animal protection movement with one professional, clear, and unified position on key animal issues.
